The Participants hereby indemnify and agree to save harmless the Tournament, Tsunami Fishing Systems and their respective owners, directors, employees, volunteers, agents, partners, members and/or attorneys (collectively the "Tournament Indemnified Parties"), from and against any and all claims that arise from or in connection with any negligent act or omission of the Tournament Indemnified Parties.

All persons connected directly or indirectly with the operation of the Tournaments, whether individual or corporation, shall have no liability whatsoever for any special, incidental, consequential, punitive, exemplary and/or any other damage including without limitation, any damages arising from libel, slander, loss, damage, negligence, harm, injury or death.

The Tournament Committee reserves the right to refuse entry to any boat, team or person.

Participants specifically agree and consent to the use of any photograph in which they appear, or audio or video recording, by the Tournament for any purpose whatsoever including, but not limited to, resale, advertising and promotional material without compensation or restriction of any kind.
